Impact Statement

LOROS treats the person not the illness. This holistic approach involves a variety of complementary therapies which says you are a person, an individual, who matters to us.

Summary of Volunteer Role

Under the supervision and guidance of the Complementary Team Therapy Team you will provide short treatments to Day Therapy patients and staff.

Key Volunteer Duties

- To assess each patient/carer individually.
- Assess holistically and adapt the therapy to deliver a safe complementary therapy session to patients/carers/staff.
- To feedback to the multidisciplinary team if you have any concerns.
- Documenting all treatments and any oils used.
- Maintain CPD file and insurance.
- Attending Team meetings where appropriate.

Essential Requirements

- A successful DBS Check
- Must hold Level 3 Diploma in Aromatherapy or Reflexology
- Have own Therapy Insurance & maintained CPD
- Must have received two COVID vaccinations if operating from the hospice

Personal Qualities to fulfil role

- Flexible and adaptable to meet the needs of the client
- Good communicator and listener
- Team worker
- Honest and reliable
- Friendly
- Have the ability to deal with sensitive and distressing situations
- Must be able to respect client confidentiality whilst being mindful of safeguarding reporting

Learning and Development required to fulfil role

Role specific Off the job training

- Personal Manual Handling Training

- The service provided is tailored to meet the needs of the patient and their relatives/carer/staff, as a volunteer there is requirement to adapt according to how the client is feeling on the day.

On the job training carried out by the manager, volunteer buddy or volunteer co-ordinator
